

AJLPA BOARD OF DIRECTORS

OFFICER RESPONSIBILITIES

PRESIDENT

Bylaws: "The President shall preside over all meetings of the AJLPA and the Board of Directors and will be held accountable to the AJLPA membership, the Board of Directors, and the ALPA Executive Committee."

Responsibilities Include:

- Obtaining a positive attitude towards AJLPA and ALPA
- Leadership of AJLPA Board of Directors
- Collect sponsorships for AL Born and Bred Livestock Show and AL Born and Bred Divisions in additional shows
- Active participation in AL lamb shows as an exhibitor and assist show admin with Born and Bred divisions.
- Attendance at ALPA sponsored shows and functions- including but not limited to the AL Born and Bred Show, ALPA banquets, AL lamb shows with Born and Bred divisions unless in the case of emergency. (example: medial, family, or unforeseen circumstances)
- Speak at ALPA end of season banquet updating ALPA members with the growth and activity of the junior board.

VICE PRESIDENT

Bylaws: "The Vice-President shall assume the President's responsibilities in the event that the President is absent from an AJLPA meeting or a meeting of the AJLPA Board of Directors."

Responsibilities Include:

- Obtaining a positive attitude towards AJLPA and ALPA
- Leadership of AJLPA Board of Directors
- Assist the AJLPA President in any task needed
- If the President cannot attend a meeting or event, Vice President will attain responsibilities of president
- Collect sponsorships for AL Born and Bred Livestock Show and AL Born and Bred Divisions in additional shows
- Active participation in AL lamb shows as an exhibitor and assist show admin with Born and Bred divisions.
- Attendance at ALPA sponsored shows and functions- including but not limited to the AL Born and Bred Show, ALPA banquets, AL lamb shows with Born and Bred divisions unless in the case of emergency. (example: medial, family, or unforeseen circumstances)

SECRETARY

Bylaws: "The Secretary shall record and keep minutes at each AJLPA meeting and Board of Directors meeting. Such record shall be subject to review and scrutiny by the Board of Directors and the ALPA Executive Committee."

Responsibilities Include:

- Obtaining a positive attitude towards AJLPA and ALPA
- Recording and keeping minutes at all AJLPA meetings and Board of Directors meetings.
- Take pictures during Alabama Born and Bred divisions, shows, and functions for Social Media platforms.
- Write updates and posts for AJLPA and ALPA social media platforms to be given to the AJLPA sponsor.
- Collect sponsorships for AL Born and Bred Livestock Show and AL Born and Bred Divisions in additional shows
- Active participation in AL lamb shows as an exhibitor and assist show admin with Born and Bred divisions.

DIRECTORS AND DIRECTORS-AT-LARGE

Responsibilities Include:
